Where is Loch Sport?

Loch Sport is on the southern shore of Lake Victoria on the Gippsland Lakes.

Loch Sport is surrounded by Coastal Parks, 90 mile beach and adjacent to the Lakes National Park which creates a unique natural waterfront environment all around the lakeside town.

The town also has a Marina, Hotel, RSL, Caravan Park, Bakery, Numerous Holiday Acomodation & a number of Caf es and Take Away shops a Service Station, supermarket and other attactions. Boat Club, Bowling club, tennis court and Golf club.

Loch Sport is around 2½-3 hours drive from Melbourne via Traralgon then Sale via the Princes Highway.

What is a Poker Run?

A Poker run is not a race. It's a game of chance. A Poker Run is fun on the water, boating at its most enjoyable, and a chance to renew old acquaintances and make new friends. Poker Runs are for the entire family.

Each boat follows an easy course, stopping at checkpoints along the route to pick-up a sealed envelope containing a single playing card.

At the final checkpoint, the envelopes are opened and the crew holding the best poker hand is declared the winner!

A Poker Run is an organised, activity orientated, fun filled event.

Naturally it helps to have a great body of water, but equally as important are the card stops and special activities for entrants throughout the poker run.

Conditions of Entry

I acknowledge and agree that:

1. In this Event application and declaration: "Club" means and includes: Loch Sport Boat Club Inc. and its directors, officers, members, servants or agents. "Claim" means and includes any action, proceeding, claim, demand, damage or expense however arising including but not limited to negligence but does not include a claim against the Club under any right expressly conferred by its constitution.
2. If accepted I will be permitted to participate in the Event subject to my complying with the terms and conditions of the Event, this declaration and any reasonable direction issued by the Event organisers or their representatives.
3. This document cannot be amended. If I do amend it my application will be null and void. It cannot be accepted by the Club.
4. The Event rules & this declaration comprise a contract between me and the Club and are necessary and reasonable to promote and conduct the Event.
5. Warning: Participation in the Event can be inherently dangerous I acknowledge that I am exposed to certain risks during my participation in the Event including, but not limited to, physical exertion and injury, bodily contact, falls, equipment failure and unpredictable weather conditions. I acknowledge that accidents can and often do happen which may result in me being injured or even killed, or my property being damaged. I have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.
6. Exclusion of Implied Terms: I acknowledge that where I am a consumer of recreational services, as defined by any relevant law, certain terms and rights usually implied into a contract for the supply of goods or services may be excluded. I acknowledge that these implied terms and rights and any liability of the Club flowing from them, are expressly excluded to the extent possible by law, by this event declaration. To the extent of any liability arising, the liability of the Club will, at its discretion be limited to the resupply of the services or payment of the cost of having the services supplied again.
7. Release and Indemnity: In consideration of the Club accepting my application for entry to the Event I:
 - (a) release and will release the Club from all Claims that I may have or may have had but for this release arising from or in connection with my participation in the Event; and
 - (b) indemnify and will keep indemnified the Club to the extent permitted by law in respect of any Claim by any person including but not only another participant in the Event arising as a result of or in connection with my participation in the Event.
